# Overview

From 2024 ACSL will provide a new model of safeguarding services to Catholic organisations, supporting a national approach to safeguarding within our Church to ensure a safe church for everyone.



## The Role of ACSL in the Catholic Church

ACSL promotes and supports a nationally consistent, comprehensive, and sustainable framework for ensuring a safe Church for everyone. It was established following the Royal Commission into Institutional Responses to Child Sexual Abuse.

All Catholic leaders in Australia, across all ministries, support Pope Francis in his call for greater accountability and transparency in how we protect and support the most vulnerable in our communities.



## Responding to the findings of the Royal Commission

All parts of the Catholic Church have been committed to meeting the recommendations of the Royal Commission. Five years from the final report, the National Catholic Safeguarding Standards underpin our national approach to safeguarding.



## Strengthening the Church's safeguarding culture

The Australian Catholic Bishops Conference, Catholic Religious Australia and the Association of Ministerial Public Juridic Persons, with the Board, want to open ACSL's services to organisations beyond the three owner bodies, to continue to promote a national and consistent culture of safeguarding and continuous improvement across the whole Church.

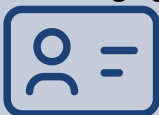

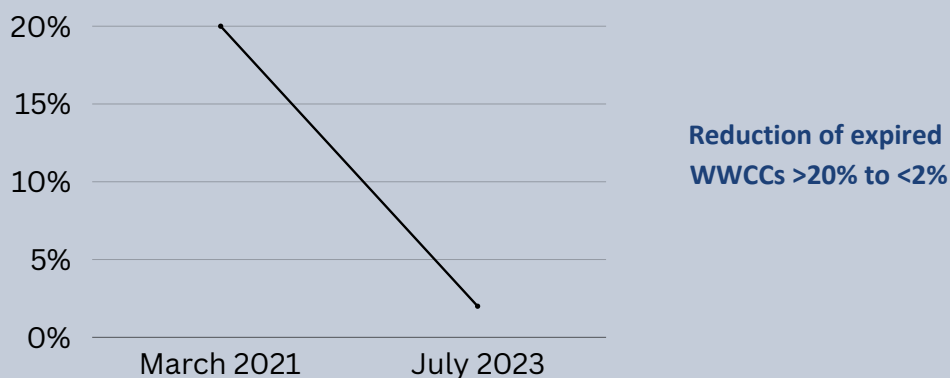

# ACSL's Role in Our Common Mission

Our Common Mission is a code of conduct for everyone involved in Catholic ministry and service. ACSL plays an integral role in assisting adherence to the suite of documents that make up *Our Common Mission*.

Managing the **National Database** providing archival searches to victims, individuals and Church Authorities as required.

Administering the **Australian Catholic Ministry Register** and **Catholic Formation Ministry Register**.

Maintaining and refining risk-based review criteria for regular **Audits and Reviews** of safeguarding policies and practices.

Working with Members and State and Territory regulators to promote the safety of all who come into contact with Church Entities.

Supporting Church Authorities to implement and maintain **Professional and Safeguarding Standards** and a Complaints Handling Policy.

Publishing **guidance notes on emerging issues** for safeguarding and professional standards offices.

Assisting Church Authorities to comply with safeguarding obligations under **Commonwealth and State or Territory laws**.

Providing an **independent process for complaints** against a Church Authority where not provided for under Vos Estis Lux Mundi.

Providing **expert safeguarding advice**, training, and support to Church Authorities.

Acting as a **policy, research and resource hub** for Catholic entities.

Maintaining and reviewing the **National Catholic Safeguarding Standards**.

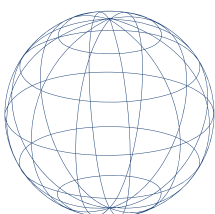
Providing a **review mechanism** for complaints managed under a Complaints Handling Policy.

Providing training, approval and support to **external auditors**.

Identifying and managing appropriate safeguarding **data collection**.

**Reporting** the results of Safeguarding Audits and Reviews.

Managing the **national 1300 contact number** for victims and survivors.



ACSL contributes to global thought leadership in the emerging discipline of safeguarding.
